The Salesperson Course– 54 Hours

You are required to take approved pre-licensing courses before you are eligible to take the state real estate exam, and with that in mind, the TUCKER SCHOOL OF REAL ESTATE has a Salesperson curriculum which will teach you all the fundamentals you'll need. The Broker Course– 54 Hours

State Exam

The state licensing exam is given every Tuesday through Saturday twice a day. In your class you will receive information on scheduling the test.

License Requirements

Salesperson

- 18 years of age
- Attendance of a minimum of 14 of 18 class sessions
- 54 hours of classroom instruction
- Minimum total score of 225 points (of 300) on three required exams

Broker

- 18 years of age
- Attendance of a minimum of 14 of 18 class sessions
- Minimum total score of 150 points (of 200) on two required exams
- 54 hours of classroom instruction
- Successful completion of approved pre-licensing Salesperson course
- Successful completion of State License examination
- One year active salesperson license prior to exam
